

COMPETITION RULES

Questionnaire – End of year festivities
From 08 to 22 November 2022
(“the Rules”)

Description of the competition

The **Société Anonyme des Bains de Mer et du Cercle des étrangers à Monaco**, whose registered office is located at Place du Casino 98000 Monte-Carlo - Principality of Monaco, is holding a competition (**the “Competition”**) which will take place online via the Review Pro platform from Tuesday 08 November to Tuesday 22 November 2022 inclusive.

A) Entrants (“the Entrant(s)”)

Only adult recipients of the MICE emailing sent on 08 November 2022 are allowed to enter the Competition. Simply entering the Competition implies acceptance of all the provisions of these Rules.

Members of staff of the Monte-Carlo Société des Bains de Mer Group and its subsidiaries are not allowed to enter the Competition and neither are their families.

B) Entry terms and conditions:

The Competition consists of asking Entrants to complete an online questionnaire.

The winner will be selected in a prize draw at the end of the Competition period.

Online Competition questionnaire: Entrants must answer all the questions and provide their contact details (surname, first name, email address, country)

The Competition period lasts from 08 November to 22 November 2022.

Article 2: Rules (the “Rules”)

Entry in the Competition implies acceptance of these Rules in their entirety, as well as the laws, ordinances and other legislation applicable in the Principality of Monaco. The Rules therefore apply to any Entrant in the Competition. They are exclusively governed by Monegasque law. The Regulations are available on the Société des Bains de Mer website.

Article 3: Prizes

A) Winner Prize Draw

The winner will be drawn on 22 November 2022.

The draw will be made behind closed doors, in the presence of a member of the Société des Bains de Mer Sales Department. The winner will be notified by email.

The decision is final and cannot be contested.

The prize will be sent after 22 November by post. Only Entrants who have complied with each stage of the Competition will be eligible for the draw.

B) Description of the prize

1 night at the Hotel Hermitage Monte-Carlo, in a Suite, with breakfast for two people.

This prize can be used until 31 December 2023, subject to availability, except during peak season (1st and 02 January 2023, from 07 April 2023 to 16 April 2023, 05 May 2023 and 06 May 2023, 12 and 13 May 2023, from 09 June 2023 to 30 September 2023, 22 December 2023 to 06 January 2024), Grands Prix (from 25 to 28 May 2023) and blackout dates (18 May 2023, 02 and 03 October 2023, 11 and 12 October 2023)

Article 4: Withdrawal of the prize

The prize awarded will not be taken back, exchanged, resold or refunded, even partially.

Article 5: Disputes

The Management of S.B.M. has primary jurisdiction for the settlement of disputes that may arise during the course of the Competition or for the application of these Rules.

The Management of S.B.M. and the Entrant shall however endeavour to settle amicably any dispute resulting from the application or interpretation of the Rules, before initiating any procedure whatsoever that would be subject in this case to the Courts and Tribunals of the Principality of Monaco, with the application of Monegasque law alone.

Article 6: Liability

S.B.M. shall not be liable if, due to force majeure or events beyond its control, the dates and/or times should be changed and/or cancelled.

S.B.M. reserves the right to take legal action against anyone who has committed fraud or attempted to do so. However, S.B.M. shall not incur any liability whatsoever towards the Entrants as a result of any fraud committed by third parties.

In particular, the fact that an Entrant registers and then enters the Competition under one or more fictitious aliases or under identities borrowed from one or more third parties will be considered as fraud, as each Entrant must register and enter the Competition under his/her own name. Any fraud results in the Entrant being eliminated.

In the event of default by an Entrant, S.B.M. reserves the right to automatically disqualify any entry by the Entrant, without the Entrant being able to make any claim whatsoever.

Article 7: Personal information

By entering the Competition, the Entrant agrees to disclose his/her personal information, intended only for the Monte-Carlo Société des Bains de Mer Group. With the Entrant's express consent, Monte-Carlo Société des Bains de Mer will be able to share personalised commercial offers through all of the communications channels you have provided for this purpose.

In accordance with Law no. 1.165 of 23 December 1993 as amended, on the protection of personal data, and with the legislation in force in the Principality of Monaco, any Entrant in the Competition has the right to access, rectify, oppose and erase any nominative information provided. This right may be exercised by sending an email together with proof of your identity to data-privacy@sbm.mc or by post to the Data Protection Officer, Société Anonyme des Bains de Mer et du Cercle des Etrangers à Monaco, Place du Casino, MC 98000 Monaco, Principality of Monaco.

These personal data are kept for the duration of the Competition and its effects.
