

# INTERNAL RULES



## REGISTRATION AND ADMISSION

### Article 1

Access to the Monte-Carlo Kids Club by Petit VIP is reserved for children of Hotel and Monte-Carlo Beach Club guests aged between 4 and 12 years old, subject to availability of 30 places.

### Article 2

A registration form, distributed by the Monte-Carlo Kids Club by Petit VIP, must be completed and signed for each child's registration.

### Article 3

The child must be accompanied by a parent or an authorised person on arrival at and departure from the Monte-Carlo Kids Club by Petit VIP.

The Ambassadors will take charge of the child as soon as the parent(s) or the authorised person authorised of the Monte-Carlo Kids Club by Petit VIP, who must be present at the Hotel and/or the Monte-Carlo Beach Club during the time the child is taken in charge, leaves.

The child will only be returned to the person who dropped off him/her or to the authorised person mentioned on the enrolment form. If necessary, an identity check may be carried out by the Ambassadors.

## OPERATION AND RECEPTION

### Article 4

The Monte-Carlo Kids Club by Petit VIP is open every day from 29 June to 31 August from 10am to 5pm. The Hotel reserves the right to modify the opening hours or even temporarily close the Monte-Carlo Kids Club by Petit VIP. Where applicable, information will be available at the hotel reception desk and in the Monte-Carlo Kids Club by Petit VIP area. Evening dinners are offered on Tuesdays and Fridays from 7pm to 10pm.

### Article 5

Families must respect the timetable and arrive at the meeting point five minutes before the start of the workshop. In the event of late arrival, the Monte-Carlo Kids Club by Petit VIP may decide not to accept the child.

### Article 6

The number of children from 4 to 7 years old welcomed at the same time is set at 6 per Ambassador and 10 per Ambassador for children from 8 to 12 years old.

Places are limited to ensure that the workshops run smoothly.

It is the responsibility of the parent(s) or official accompanying person(s) to register the child for the workshops.

No reductions or refunds will be given if the child is absent from activities.

## HEALTH AND SAFETY

### Article 7

The Monte-Carlo Kids Club by Petit VIP cannot take care of children requiring special medical supervision or the exclusive assistance of a third party.

If necessary, children may be accompanied by a parent or an official accompanying person.

### Article 8

On arrival at the Monte-Carlo Kids Club by Petit VIP, the parent guardian or official accompanying person must indicate any allergies the child may have and his/her dietary habits on the registration form.

Meals and snacks for children with high-risk allergies (e.g. gluten) may only be given by one of their parents or official accompanying person.

### Article 9

Only children who are not suffering from a contagious disease and/or do not have a fever over 37.9°C will be accepted at the Monte-Carlo Kids Club by Petit VIP.

Children who have been ill will only be accepted if they produce a doctor's certificate, 24 hours after the symptoms have disappeared, authorising them to take part.

Hotel management reserves the right to require strict isolation of the child from the premises, particularly in the event of chickenpox or any other infectious disease, whatever its stage.

### Article 10

Smoking and vaping are strictly prohibited on the premises of the Monte-Carlo Kids Club by Petit VIP.

### Article 11

Ambassadors are not authorised to give medicines to children.

### Article 12

In the event of a medical emergency, the Hotel management and the Ambassadors will take the necessary measures to safeguard the child's health and will contact a doctor or emergency services.

A parent or an official accompanying person will be informed immediately.

### Article 13

The parent(s) or official accompanying person(s) must ensure that there are no contraindications to practising the sports proposed in the programme and in particular inform the Ambassadors if their child(ren) cannot yet swim.

In the latter case, the children will not be able to take part in the water sports activities under the responsibility of the Monte-Carlo Kids Club by Petit VIP Ambassadors.

INTERNAL RULES

RESPONSIBILITY AND COMMITMENTS

Article 14

Children remain the responsibility of their parents, who must be able to be contacted at all times. The activities offered to the children are managed under the responsibility of the Ambassadors.

Article 15

Civil liability and "personal accident insurance" is required for all outings outside the Monte-Carlo Kids Club by Petit VIP. The parent(s) declare(s) on their honour that their child(ren) is/are covered by private civil liability insurance.

Article 16

Children must have an exemplary attitude on the premises and when taking part in activities at the Monte-Carlo Kids Club by Petit VIP.

Children must refrain from any gestures or words that might disturb the peace of other children or the Ambassadors.

Parents are financially responsible for any deliberate material damage caused by their child.

An alert will be sent to the parent(s) or official accompanying person(s) if the child repeatedly disrupts an activity or does not follow these rules.

After two (2) alerts, the child will be returned and excluded from all participation.

Article 17

Children must listen carefully to the instructions given by the staff of the Monte-Carlo Kids Club by Petit VIP, particularly with regard to hygiene and safety.

Children must wash their hands before and after each activity.

IMAGE RIGHTS

Article 18

In order to comply with the rules governing image rights, prior authorisation must be obtained from the child's parents before any photographs are taken.

To this end, one of the parents of the child taking part in the Monte-Carlo Kids Club by Petit VIP activities must complete a document defining the framework and use of the photographs taken and give their authorisation, or not, for their distribution for educational and/or communication purposes.

Article 19

Children are advised not to bring valuables such as jewellery, watches, mobile phones, etc. to the Monte-Carlo Kids Club by Petit VIP.

The hotel cannot be held responsible for the loss or theft of any object while the child is participating in the activities.

PERSONNAL ITEMS

PERSONNAL DATA COLLECTION

The Société des Bains de Mer, as data controller, whose registered office is located at Place du Casino 98000 Monte-Carlo, Principality of Monaco, processes your personal data and that of the child you wish to enrol in the Monte-Carlo Kids Club by Petit VIP on the basis of the contract. On the sole basis of your consent, we process the sensitive data that you communicate to us (health, diet, etc.) in the context of access to the Monte-Carlo Kids Club by Petit VIP service. In addition, your child's data is processed to take appropriate measures in the event of imminent danger to his or her health, on the basis of the need to safeguard vital interests. On the basis of our legitimate interest, for security reasons, video surveillance systems are installed on our premises in compliance with the applicable legislation.

The data collected is intended for Société des Bains de Mer establishments, whether subsidiaries or managed entities, internal departments and third parties involved in the proper execution of the above-mentioned purposes.
